In summary, and as in 2017, MLG had another successful and active year in 2018 with a wonderfully diverse range of activities & a strong and vibrant membership — so a big thank you to all our hard working and dedicated **volunteers**.

It was MLG's 21st year since incorporation & a year of diverse activities.....
We started a MLG Facebook page in June and within a few days already had 60+ followers!

MLG was part of the organising committee for the Yass Area Network of Landcare Groups very successful **Climate Forum** with over 200 attendees and where MLG sponsored a number of aspiring young Landcarers from Yass High School students to attend.

Our **MLG website** had a big makeover with a great range of new resources added to the website to provide information on a vast range of Landcare topics to assist local landowners making informed land management decisions for their properties and to undertake revegetation.

We started our journey to become "climate ready" so that MLG can provide plants and advice for revegetation suited to expected climate change for the Murrumbateman region including documenting seed provenance for MLG's current nursery species, investigating the suitability of other species, sourcing seed from areas with current climate similar to Murrumbateman projected climate and other strategies to lead to best adapted plants for revegetation into the future.

Provided information to members on other regional landcare events and advice to local community organisations and the Barton Highway Upgrade Planning team for environmental planning.

Our **MLG** native plant community nursery held many working bees with many volunteers turning up to help whenever they could producing again lots of local native plants. Also nursery managers Lisa and Gill's work with their volunteers has been recognised and rewarded with another \$1,000 Landcare Australia grant for activities and materials.

We had extensive range and number of presentations, discussion nights and field days which included:-

- a native plant cuttings for propagation day in March
- March Farm Visit via Kaveneys Road to identify best practice management for revegetation, pasture management, plant ID, sourcing appropriate native plants and site preparation
- May Part 1 of the climate change content a film "The Wisdom to Survive" with Part 2 YAN climate change day later in May
- July 'Planning for planting a guide to plant selection for your property'
- August 'Glimpse the private life of fauna with trail cameras'
- September 'Solar generation and storage/Electric cars'
- October Murrumbateman Field Days and helping organise another fantastic display of Landcare activities in the large Landcare and South-East Local Land Services marquee
- Late Spring wildflower walk at 'Gunyi' in November 2018

The year ended with **Sue McIntyre's** 2018 Landcare award, AGM and Christmas Party at the Gundaroo Pub!! We look forward to another great year with all our members in 2019

Notes

- (1) At 30/6/18, MLG had three accounts a main operating account that receives revenue and is used for large outlays, an account allowing the treasurer to make small EFT payments and a term deposit.
- (2) The funding for our major project, LLBIII, finished in June 2017, though related activities continued in 2017-18 in the form of MLG funded projects meeting LLBIII criteria.
- (3) Nursery income was separately identified from 2016-17. Expenditure was separately identified from 2011-12.
- (4) The composition of this item has varied over the years. From 2016-17, it included bank fees and refunds. From 2017-18, it also includes petty cash allowance and myna bird expenditure.
- (5) From 2012, *Non-financial members* excludes long-term non-financials, who are presumed to be effectively lapsed. Periodically, these members are contacted and removed from our mailing lists if they are not interested in being involved. There are currently 30 long-term financials on our list.
- (6) From 2016, the membership year was changed to start at 1 July instead of 1 September.
- (7) Corporate members are separately identified and include related organisations, such as Greening Australia and Friends of Grasslands. They do not pay subscriptions. Data are not available for previous years.
