




- Invest in our people to build an engaged, professional, customer-oriented and highperforming organisation.






### **Statewide Outcomes**

In just over a year, the BCT has entered **84 new conservation agreements** with private landholders in NSW, covering more than **19,000 hectares** and representing an investment of over **\$55 million** for the BCT. In this time the BCT has also made **36 grants** to existing agreement-holders to help them maintain the ecological values of their properties.

Many rare or threatened species, ecosystems and **29 priority NSW landscapes** are being conserved under these agreements. Examples of **threatened fauna species** in these landscapes are:

### Activities in the south east region April 2019


- Attempted contact with ~450 agreement holders
- 21 new conservation agreements, 20 in preparation, 10 on-hold (1153 hectares under conservation management)
- 17 grants being processed
- Exploring partnerships assistance to roll out programs
- Strategic planning for the next 18 months
- Education strategy in development
- Wildlife Refuge review (174; 26% of total in NSW)
- Offset Program establishing credit supply



### **Conservation Partners Program:**

- In perpetuity Conservation Agreement or Wildlife Refuge
- To be eligible for a Conservation Agreement: Sites must be over 20 hectares in size and in good to moderate condition
- Benefits:
  - ✓ Recognised permanent protection
  - ✓ Rate relief
  - ✓ Possible land tax benefits
  - ✓ Apply for Grants: up to \$15,000 per year for three years
  - ✓ Landholder technical support



## **BCT Grants Program**



- 1. Up to \$15,000 per year for up to three years for landholders with: in-perpetuity Conservation Agreements, Trust Agreements, Registered Property Agreements
- 2. Up to \$8,000 per year for up to three years for landholders with: a term Registered Property Agreement
- 3. Up to \$2,000 per year for up to three years for landholders: with a Wildlife Refuge, or who are members of Land for Wildlife or Wildlife Land Trust

#### The following activities are supported:

- Fencing—installation, repairs or replacement of wildlife-friendly conservation-related fencing Weed control
- Introduced pest animal control
- Supplementary planting, revegetation or vegetation enhancement
- Habitat restoration
- Other maintenance—such as tracks or erosion control needed to maintain a conservation value

### **Biodiversity Offset Program**

Biodiversity credit conservation tenders

reverse auction process.

Landowners bid to sell credits to BCT.

Established and new BSA holders may be eligible.

Biodiversity credit fixed price offers

BCT publishes fixed price for sought-after credits.

BCT will buy credits from first offer at advertised price (subject to eligibility requirements).

The BCT will release detailed information regarding tenders and fixed price offers via website and direct notifications to BOS participants.

Registering an EOI is a good way of ensuring you are notified about upcoming tenders and fixed rate offers.



### **Conservation Management Program:**

Protects landscapes that are unrepresented and inadequately reserved, and diversifies income for landholders

#### Conservation Tenders:

A 'reverse auction' where landholders are invited to submit bids and set their own price Successful applicants put forward the highest value conservation area for the best price

#### Fixed Price Offer:

Targeted fixed price per hectare based on Land Capability Class


Minimum 50 hectare in perpetuity Conservation Agreement High conservation Value and Vegetation in good to moderate condition

#### Revolving Fund



#### **Fixed Price Offer**

- Targeted application of a fixed rate per hectare per year set by the BCT
- Highest priority NSW landscapes within biogeographic subregions that are least protected in NSW
- Minimum size of 50 hectares
- Contain high conservation value assets
- Moderate to good condition
- In-perpetuity agreement that must be registered
- Schedule on website; rates set by land capability class (1-8)
