## ENVIRONMENTAL WATERING

The Yanco Creek System has been included in the environmental watering monitoring of the Murrumbidgee Valley since 2021. This is undertaken on behalf of the Commonwealth Environmental Water Holder by Charles Sturt University and in recent years Andrea Mitchell has been involved in some of the on-ground work.

Delivery of environmental water is increasing the total volume of water within the system. Irrigation water orders are no longer enough to experience consistent flows to the levels historically experienced. This is due to the reduced water entitlements that are now held in the YCS. Essentially environmental water orders are needed to keep the creeks flowing. Below shows the volume of water that has flowed through the system since 2014/15.

So far, this current year 19,700GL has entered the Yanco Billabong Creeks.


Wanganella Swamp has not received any environmental flows for the past two years as it has been wet and the SDLAM project team needed to survey the area.

Recent low flows were experienced in the Yanco and Billabong Creeks for various reasons. We reached out to WaterNSW, CEWH and NSW DQ to increase flows and are grateful to the federal and state environmental water departments as they committed an environmental flow to ensure flows in the system were kept at a consistent level, rather than quick increases and decreases to mirror irrigation water orders.



At the recent EWAG meeting a further commitment was made to 30 June 2024 to continue to supplement water orders by adding an environmental water order for flows to 500ML day at the Yanco Offtake.

Wetland monitoring sites are recording frogs, bats, fish, turtles and waterbirds. This monitoring will enhance the general understanding of the Yanco Creek System and feed into future funding opportunities.



The ongoing program will cover the next 5 years, so we eagerly look forward to the change over time and to be recognised for the unique wetlands we have within the system.
