Background & Context

The development and implementation of actions to build engagement between the Landcare movement and Aboriginal people as been an ongoing priority at the grass-roots level over the last 10 years or more.

This new and innovative component of the NSW Landcare Program, will build relationships, set the groundwork, develop principles and install an advocacy role at Landcare Executive and Landcare Council Level.

This component of the NSW Landcare Program will increase opportunities to consciously develop stronger connections and partnerships between Landcare groups and Aboriginal Communities practicing Traditional Land Management practices. A full time Aboriginal Communities Engagement Coordinator will be employed by Landcare NSW Inc. This officer will work with a Steering Committee to identify the most effective approaches in supporting Aboriginal People to have a voice within Landcare, to connect them with local Landcare Communities and to help share Traditional Land Management approaches.


