I usually start with a comment on the Yanco SDLAM Project but as our AGM is only a few weeks away and Matt Barden (Project Manager SDLAM Yanco Modernisation) is providing an update at the meeting, I strongly encourage all members to attend so you can hear directly from the SDLAM team.

Dealing with bureaucrats is not easy or rewarding at times. I tried to pin down the department responsible for invasive fish species in NSW rivers recently. I contacted CEWO, WaterNSW, Fisheries, MDBA before finally being directed to Dept Primary Industries, who I believe responsible for ‘management’ of invasive species. I will be following up with them soon.

After nearly 3 years of high flows we are seeing carp in plague proportions and the water quality is as ordinary as I have ever seen it. Turbidity levels at the moment are 500+NTU, a clear water reading is at 50NTU. Prior to the introduction of European carp, our creek system ran clear water. If we are facing lower flows due to El Nino, the underlying issues need to be addressed or we will be facing fish kills similar to other rivers (Darling springs to mind). As carp continue to plough the bed of the river system there is a loss of aquatic plants and grasses which then increases nitrogen and phosphorus levels allowing algal outbreaks and low dissolved oxygen levels leading to fish kills, it also has a huge impact on native fish breeding with carp destroying fish nests. With 95% of our large fish population now carp, it is now time for a national approach to address these pests.

IPART approved an increase of 7% in WaterNSW bulk water charges and now are working on a price determination for 2025-2030. The determination will include: cost structure (what irrigators should pay for), % of recovery (up to full cost recovery), % of fixed charges (currently 40% fixed, WaterNSW to increase fixed ratio to 90%+), never good news for irrigators with variable allocations.

The MDBP will not be completed by June 2024, so the uncertainty continues. Now that Buybacks are back on the table, the Yanco Creek System could be significantly affected. Every time water is removed from the system you have to rely on NSW or Commonwealth environmental water to maintain healthy flows.

I wish I could provide a more positive report but irrigators are facing a uncertain future with buybacks, climate change and other factors affecting their businesses.

I am sure Tanya and Andrea will have much better news. Cheers Trevor

Grant Funding

I have been working on sourcing funding to compliment the YCS Levy funds for works on the Yanco Creek System. Some of the funding recently received is listed below:

- Murrumbidgee Council Community Grants \$1,100
- DPI - Fisheries \$2 for \$1 native fish stocking program \$12,000
- Murray LLS - Rolling Out All Resources \$33,650
- Foundation for Rural and Regional Renewal (FRRR) \$40,100

Rolling Out All Resources (ROAR) Project

In two days (September 6 & 7) almost 500 kgs of carp were electro-fished from a 5 km stretch of the Billabong Creek in Conargo! Electrofishing, fish surveying, wetland planting and golden perch fingerling release form part of YACTAC's ROAR project funded through the Refreshing Rivers Program to enhance waterways. The aim of fish surveying, pre and post electrofishing, is to quantify native fish response, survival and growth to carp removal. Fish ecologist, Dr John Conallin, was out on the weekend surveying fish and will continue to do so in the coming months. To boost native fish numbers funding through NSW DPI's Fish stocking program grant has ensured



27,000 golden perch fingerlings will be released at Conargo in February 2024.

Conargo Primary School wrote that students, teachers and adults from the school attended and learnt the difference between native species and carp. Both male and female carp were caught and this allowed participants to see the difference in size between the two genders. The fish are only stunned by the electro technique and native fish swim away, whilst the carp are scooped up in nets and removed.

Rolling Out All Resources (ROAR) Project - continued

In addition to the carp removal, activities also took place on the banks of the Billabong Creek at the Conargo TSR. Three hundred tubestock plants, of various species, were planted by Deniliquin and Conargo students with the help of Deniliquin Kolety Lagoons Landcare Group, YACTAC through the Refreshing Rivers Program and Murray Local Land Services. Morning tea was held on the banks of the Billabong Creek and a great day was had by all.

Challenges

I returned to work after some much needed leave to find so many challenges facing our members. Minister Plibersek's recent announcement about moving the water recovery deadline and more buybacks has sent shockwaves through the southern basin. Her Water Amendment (Restoring Our Rivers) Bill 2023 clearly states that buybacks will be part of the mix and the 'cap' will no longer apply, which could lead to large amounts of water being taken out of circulation. All SDLAM projects are tied up in the Bill, so the outcome will have a direct link to Yanco.

WaterNSW has been allowed to increase 2023-2024 water charges by 7%. The next pricing determination covers 2025-2030 and it is expected that the cost to irrigators will be increased significantly. WaterNSW held their first Engagement session on pricing and only 14 people attended for the Murrumbidgee and Murray Valleys. IPART directed WaterNSW to engage more broadly to determine where WaterNSW places their focus and spending. I urge you to get involved. Contact Fiona Court (fiona.court@secnewgate.com.au) to register your interest.

The NSW Regional Water Strategy was commenced in 2021, with 14 strategies being developed across the state to provide a long term list to deliver 5 objectives. A review of the Stock and Domestic license category is currently under way. There is a survey open (until 21 Nov) which I urge every one of you to complete. Questions covering level of regulation and access, permitted uses, Basic Landholder Rights are just some of the topics. You need to engage to have your say and it only takes 10 minutes.
