# NSW Biosecurity and Food Strategy 2022-2030

---

The NSW Biosecurity and Food Strategy 2022-2030 sets objectives for biosecurity and food safety in NSW. This Strategy provides guidance to the management of risk posed by the interdependencies between people, plants, animals, food, and the environment, to promote sustained wellbeing and economic prosperity.

Biosecurity and food safety is a shared responsibility - industry, research, government partners, and the community working together to ensure four strategic objectives are met:

1. Prepare and prevent - adopt innovative solutions to effectively manage future and emerging threats through improved prediction, early detection and better understanding of risk pathways.
2. Timely and risk proportionate responses - make informed and risk-based decisions to proportionately respond to biosecurity and food safety threats.
3. Rapid and efficient containment - minimise the adverse impacts of biosecurity and food safety threats on economy, environment, and community, while also maximising product integrity and market access opportunities.
4. Partnerships to minimise impacts - engage stakeholders and share responsibility to minimise the impact of biosecurity and food safety threats, including exotic and endemic pests, diseases and weeds, and foodborne illness.

The Kunming-Montreal Global Biodiversity Framework outlines 23 action oriented global targets for urgent action over the decade to 2030.
